The property will be located in Avenida Diego Martínez Barrio, 2 at the crossroads with Avión Cuatro Vientos Street, in what is considered the "Milla de Oro" of Seville. This district, where land availabi-

lity is scarce, offers optimal accessibility and immediate proximity to the historic centre, key monuments, the railway station, and the airport. As a key district of the city, Nervión is Seville's economic and business hub, hosting numerous corporate headquarters and service companies, thus providing a strategic location for both leisure and business clientele.

The hotel, scheduled to open in the first quarter of 2028, will feature 184 rooms and a full range of amenities, including a restaurant, a bar, a rooftop with panoramic swimming pool, a fitness centre, three flexible meeting rooms (101 sqm) and 40 parking spaces. The building is targeting a BREEAM Very Good certification, reflecting EXTENDAM's strong ESG commitment.

The hotel is set to operate under an international brand, ensuring optimal visibility to both domestic and international customers.
